## Introduction

The Northern Planning team monitors the activities of local planning authorities to identify opportunities for clients. This monitoring report has been created to provide a snapshot of the current planning policy position for the local authorities in the North West; alongside identifying local authorities where consultations on emerging planning policies are live or expected imminently. Based on the latest available documents we have also sought to identify the relevant five-year housing supply position and have provided a snapshot of how local authorities have performed in delivering their housing requirement through references to the Government's Housing Delivery Test scores.

The report covers all of the local authorities in the North West, with the exception of the newly created unitary authority of Cumberland, which includes the previous district authorities of Allerdale, Carlisle and Copeland. Cumberland will be producing its own local plan, but given the infancy of the authority, limited work has taken place at present. The policies of the adopted Local Plans of the previous Cumbrian district authorities remain the statutory development plan for their relevant areas until Cumberland adopts its own local plan.

The Levelling-up and Regeneration Act 2023 (LURA) gained Royal assent on 26 October 2023. It introduces a new local plan system. This includes a streamlined 30-month local plan preparation period, the introduction of design codes as part of the statutory development plan, and the introduction of National Development Management Policies. Whilst secondary legislation will be required to enact the new local plan system, in a letter to local authorities in September 2023, Michael Gove stated the intention to enact legislation and draft the necessary policy and guidance to enable the first "new-style" local plans to be in place by Autumn 2024.



The letter from Gove reiterates that the Government expects local authorities to continue adopting local plans in the interim, and the LURA does contain transitionary arrangements for authorities currently preparing Local Plans. However, we have seen many local authorities delaying consultations on their local plans over the past 12 months citing uncertainties over future Government policy, including revisions to the National Planning Policy Framework (NPPF). According to the HBF, 62 local authorities across England have paused work on their local plans. As this monitoring report shows, this includes a number of local authorities in the North West.

The map to the right provides a summary of the current status of strategic and local plans across the region. It shows that the majority of local authorities in the North West have a local plan that is more than 5 years old.

Whilst there has still been no announcement from the Government, a revised NPPF is expected to be published before the end of 2023, much along the lines of the consultation version in late 2022. Given the LURA has Royal assent and a revised NPPF is imminent, we may expect that many local authorities will recommence work on their local plans shortly. Additionally, given that Greater Manchester's joint spatial framework, Places for Everyone, is expected to be adopted within the next 6 months, it is anticipated that a number of the Greater Manchester local authorities will commence work on their local plans. The Liverpool City Region Combined Authority has also re-commenced work on its draft Spatial Development Strategy after a long pause, with a consultation taking place during December 2023 to February 2024.

There may therefore be lots of opportunities over the next 6 months to influence local plans and promote sites.
